

- Call for Applications 2022 EUTIM Fellowship Program. The European University Viadrina and the University of Potsdam invite scholars to apply for a three month Visiting Fellowship in 2022 within the framework of the project "European Times - A transregional Approach to the Societies of Central and Eastern Europe". Location: Frankfurt (Oder) or Potsdam. Closing date: February 15, 2022. Background of the project: "Europäische Zeiten/European Times - A Transregional Approach to the Societies of Central and Eastern Europe (EUTIM)" is a joint project of the European University Viadrina Frankfurt (Oder), the University of Potsdam and the Forum Transregionale Studien in Berlin. It deals with narratives of time and space at the edges of Europe. Based on experiences in the societies of Central and Eastern Europe, concepts such as "old"/"new" and "East"/"West" are analysed with their temporal demarcations and localisations. Cultural phenomena of non-simultaneity are examined with regard to dynamics of de-Europeanisation and Europeanisation. In 2022, the EUTIM project will focus on "Small Literatures". The research work puts the spotlight on the influences of concepts of modernisation on small literatures, in which we observe processes of adoption, modification and reshaping of aesthetics and stylistic procedures from empires and discourse-setting cultures. In addition, accelerated and slowed-down dynamics of interweaving processes between different European cultures and literatures will be examined and reflected as modi of non-simultaneity. The three-month fellowship can start at any time between July and September 2022. The fellow will receive a monthly stipend of 2,000 €. Return travel costs from the place of residence to the place of fellowship will be reimbursed. - The role of perceptions, formed by traditions, values and beliefs, in shaping European societies and politics in the 21st century. Horizon Europe Cluster 2 Destination 2: Innovative research on the European cultural heritage and the cultural and creative industries. Budget 2022:9 000 000 euro, Type of action RIA, Deadline: 20 April 2022 17:00:00 Brussels time. Projects should contribute to all of the following expected outcomes:
- 1. Analyse the different factors that form and change people's perceptions, such as beliefs, values, traditions, economy, history, culture, age and gender, among others.
- 2. Understand in which way these factors influence and change people's perceptions, their relationship to Europe's historical and cultural past, and how they can contribute to the creation of a more inclusive vision of cultures and values, both European and global.
- 3. Apprehend the way perceptions shape European societies' understanding of and responses to the European project.
- 4. Analyse the ways in which perceptions influence society's response and preparedness during times of crisis, such as the COVID-19 pandemic and its impact on post-crisis European cohesion.
- 5. Provide recommendations to bring EU policy making closer to people, with an emphasis on young people's values and behaviour when perceiving pressing social, economic and environmental challenges. The Commission estimates that an EU contribution of between *EUR 2.00 and 3.00 million* would allow these outcomes to be addressed appropriately. Nonetheless, this does not preclude submission and selection of a proposal requesting different amounts. Scope

Proposals under this topic will identify and examine the factors that influence and change people's perceptions of the European project over time, under different geographical, political or socio-economic circumstances. Changes may also affect how people's perceptions are expressed and become visible in different media (e.g. social media, language). Research should also address the role of values and socio-political behaviour in perceiving and dealing with emergencies and economic crises, such as the COVID 19 pandemic. Lessons learnt during the COVID-19 crisis and the recovery period could be used to provide policy scenarios for facing future crises and building resilient and sustainable post-crisis societies. Finally, proposals should investigate the role of perceptions in understanding and interacting with politics and political legitimacy in the EU. They should provide recommendations on how to address these different perceptions in the policy shaping and implementation of the EU integration process.

RIA Award criteria

- 1. Excellence- Clarity and pertinence of the project's objectives, and the extent to which the proposed work is ambitious and goes beyond the state of the art. Soundness of the proposed [for the first stage: overall] methodology, including the underlying concepts, models, assumptions, inter-disciplinary approaches, appropriate consideration of the gender dimension in research and innovation content, and the quality of open science practices, including sharing and management of research outputs and engagement of citizens, civil society and end-users where appropriate.
- 2. Impact- Credibility of the pathways to achieve the expected outcomes and impacts specified in the work programme, and the likely scale and significance of the contributions from the project. Suitability and quality of the measures to maximise expected outcomes and impacts, as set out in the dissemination and exploitation plan, including communication activities.
- 3. Quality and efficiency of the implementation-Quality and effectiveness of the work plan, assessment of risks, and appropriateness of the effort assigned to work packages, and the resources overall. Capacity and role of each participant, and the extent to which the consortium as a whole brings together the necessary expertise.
