- Winter School on Federalism and Governance 2023. During the two-week training program, participants will analyze the relation between multilevel systems and the principle of equality. One aspect will center on the exploration of constitutional provisions with regard to equality and the discussion of symmetric and asymmetric federalism. Furthermore, participants will examine the impact of territorial diversities and the representation of subnational units in multilevel systems. The program will also review how multilevel arrangements might stimulate or limit individual, groups and territorial equality and provide amongst others, insights into indigenous rights and minorities in multilevel systems, as well as on the topic of segregation and desegregation in the USA. One day will be dedicated to the role of autonomous regions in Italy and the case of South Tyrol. The relation between federalism and equality is also to be discussed with regard to emerging and mature federations as well as "coming-together"-federations. The 2023 Winter School will offer in-depth sessions on (in)equalities in relation to economy, social issues, environments, and institutions. Besides numerous opportunities for discussion with leading experts on multilevel governance throughout the lectures, a variety of interactive sessions will offer participants the chance to share their knowledge and experience.
