Call for Papers

• The Future of Europe's Strategic Autonomy. Birkbeck's Jean Monnet Chair in Parliamentary Democracy & European Integration is looking for entirely new (i.e. unpublished) contributions covering both the intra- and the extra-EU aspects of the topic. These contributions could include papers on the institutional implications of the EU's strategic autonomy for the EU as a political system (incl. the question of accountability), national debates on the meaning of the EU's strategic autonomy, its connections to various policy sectors (including trade, environmental protection, industrial, energy, foreign, security and defence policies) both at the national and EU levels, as well as in relation to non-EU member states such as the UK. Additionally, contributions may explore critiques of the concept and address how it is perceived outside of the EU both by state and non-state actors. Contributions may focus on one particular aspect of the issue (e.g. its media coverage and/or public opinion analyses), or may situate the concept of EU strategic autonomy within wider theoretical debates on European integration (including core state powers and European integration), security studies, and international relations. Reflections on the concept of EU strategic autonomy in light of the evolving security framework in Europe after Russia's 2022 invasion of Ukraine are especially welcome. Deadline for the submission of proposals (max. 350 words): 15 May 2023. All proposals should be sent by email (subject: CfP, strategic autonomy) to JMC@bbk.ac.uk.

• Political Representation of Women: Global Theory and Empirical Reality from South-East Europe. Issues of political representation are a core focus of gender and politics research. Over the last four decades different approaches have been taken in order to define and empirically operationalize the concepts of 'acting, women's interests' and women's issues, some being very narrow and feminist, others very broad, incl. non-feminist definitions. Among others, researchers have examined: which women are represented, who acts in the interests of women, where the representation of women takes place, and how it is done, in addition to evaluating the quality of representation. The Journal GENERO invites authors from all around the world to submit papers related to theoretical discussions and empirical research from South-East Europe. Concretely, with this call we are looking for so far unpublished a) original research and b) review articles/state-of-art discussion. Submitted articles should be linked to at least one of the following research questions: 1. Critical actors: Who acts in the representation of women?; 2. Sites of representation: Where does the representation of women occur?; 3. Interests, issues, preferences: What does representation of women articulate?; 4. Process vs. outcome: How is representation of women expressed? Submitted articles can be country case studies or comparative articles. We encourage articles that intersect gender and politics research with other research areas and topics, including work on women's representation in post-conflict consociationalism. - (Re-)Ordering Eastern Europe. The Annual Conference of the Leibniz Institute for East and Southeast European Studies (IOS) will take place in Regensburg, Germany from 12 to 13 October 2023. The submission deadline is May 15, 2023. The 2023 edition of the IOS Annual Conference aspires to address these ongoing changes and shifts as multiscalar processes of re-ordering Eastern Europe. As we release this call for papers, Eastern Europe remains a battlefield of multiple political and violent conflicts. Russia's war against Ukraine, which has acquired a new magnitude and degree of destruction since 24 February 2022, is the major factor instigating the current wave of re-ordering Eastern Europe, likewise in terms of research on the region across disciplines. We invite proposals for contributions in particular, but not limited, to the following anticipated sessions and sub-themes: Ukraine's resilience, Russia's domestic developments both on the elite and societal level, its internal colonialism, and its (unlikely) disintegration, Digital sovereignty in times of war, International criminal courts: legacies and new beginnings, The local, regional and global dimensions of contested territories and fragmentation in Eastern and Southeastern Europe, Laboratories and experiments of (international) law in local, regional, and international politics in Eastern and Southeastern Europe, Conflicted research on and in (South) Eastern Europe. All interested authors should send either a paper proposal or a poster proposal (between 300—350 words) including a proposed title, five keywords and type of participation (panel presentation or poster presentation), the author's full name, e-mail, institutional affiliation, and a short biography (of ca. 100 words) in *one pdf file* by 15 May 2023, to events_polvr@ios-regensburg.de. - International conference on "Solidarity and support in a post-welfare era". The conference will be held in Skopje, North Macedonia on September 14-15, 2023.. The notion of solidarity spontaneously evokes a certain idea of a society grounded in values of mutual commitment and empathy toward the others. As a social practice, it manifests itself in situations of human crises - pandemics, earthquakes, war conflicts, migration and displacements due to climate and environmental changes. And yet, solidarity is also a concept that refers to fundamental social relationships taking place in everyday life, based on mutuality, sharing and reciprocity. We invite papers dealing with the notion of solidarity, well-being and welfare from different disciplines in several subthemes: Solidarity and welfare in theory and practice; Solidarity in historical perspective; Traditional forms of solidarity; Solidarity and volunteerism in socialist societies; Solidarity in capitalist, liberal and neoliberal societies; Solidarity and economies; Solidarity and political ecology; The price of solidarity: value, sacrifice, capital; Mutuality and/or reciprocity: understanding the role of the social and solidarity; Economy in the past and in the future; Solidarity and mutual support in times of recession; Solidarity and Vulnerability; Collective care as praxis; Perspectives on solidarity in humanitarianism; Informal welfare in crisis; Public health; Spaces of solidarity; Borders and buffer zones; Natural, war disaster zones; Migrant solidarity work; Religious institutions; Shapes of welfare; The political concept of welfare, welfare as a social principle, epoch or possible future. We invite submissions for presentations of up to 15 minutes. Please send proposals (300 words) to ceipa.mkd@gmail.com by May 31, 2023. Applicants will be notified of their submission status by June 20th, 2023. Abstracts should be sent in a Word document. The document should include the presentation title, a 300-word abstract, as well as the applicant's full name, institutional affiliation and contact information. - International Conference "A New-Old Neighbor. Turkish Republic and the Balkans". The Turkish Republic was the last nation-state with Balkan territories to emerge from the ashes of the collapsing Ottoman Empire, as a result of long-term painful processes (internal conflicts, military occupations, forced migration, resistance and War of Independence) and on the basis of almost total rejection of the Ottoman past. The birth of the new state had significant consequences not only for the new Turkish citizens and the Turkish and Muslim minority populations in the Balkans, but also for all Balkan peoples and, more generally, for the geopolitical balance of power in the region. The Conference aims to shift attention to the intellectual, cultural, social, and economic processes involving varying kinds of collective and individual actors and their reception of the emergence of the Turkish Republic in the various Balkan societies, and more specifically: the channels and processes through which knowledge about, images of, and attitudes towards the "new-old neighbor" and its new capital took shape in interwar Balkan societies; the continuities and discontinuities of representations with the Ottoman past; the various approaches adopted by different/rival political and social forces and institutions in the Balkan states towards republican Turkey; the impact of relations with republican Turkey on internal developments in the Balkan countries; economic relations and informal channels of transnational communication (movement of people and ideas, old and new networks etc.) and their significance for the shaping of representations; cleavages between official discourse and on-the-ground understandings of the emergent Turkish state. he conference will take place on-site, at Panteion University, Athens. We welcome submissions from senior and junior scholars and academics, as well as

doctoral students and postdoctoral researchers. Presentations will be in English and should not exceed 20 minutes. Submissions must include: a. Title and abstract (not more than 300 words) and b. Short Bio including full name, current affiliation and contact details. Proposals should be submitted by email to newoldneighborconference@gmail.com by April 30th, 2023. You will be notified about the acceptance of your proposal by May 31st 2023.

• International Research Workshop: The Political Representation and Participation of Migrants and Ethnic Minorities: Eastern Europe in a Broader Context. People belonging to ethnic groups either as a result of migration or to historical / traditional ethnic communities, representation and political participation are three major components at the core of many contemporary societies. This conference aims to gather research papers that can connect some of these components to analyze their dynamics. This conference addresses these topics from two different perspectives: the supply side of political parties and politicians who claim to represent and include ethnic minorities and migrants and the demand side of ethnic groups who participate and strive to be represented. It seeks to bring together papers aiming to better understand the complexity of this picture and to answer some of these questions, which include but are not limited to: Why do ethnic groups (minorities and migrants) participate?; How do they perceive the idea of political participation?; Who represents migrants in their home or host country?; What are the main outcomes of ethnic groups? participation and / or representation?; What are the contemporary challenges for ethnic groups? participation?; How do political parties pursue the representation of ethnic groups (including migrants in the home or host country)? - Postdoctoral Researcher for ERC project "Rights to Unite" (Advanced Grant) University College Cork (Dagmar Schiek). For the recently awarded ERC project "RIGHTS TO UNITE, UCC is now seeking to employ a Postdoctoral Researcher, as the first post for an overall project team consisting of 2 Postdoctoral Researchers, 6 PhD students, a project administrator (2 days a week) and a research assistant. For this position we are looking for a highly motivated and qualified researcher specializing in theoretical and comparative socio-legal research. You will be academically fluent in English, and potentially also in one of the other languages relevant to our project. You will be ideally familiar with the most important theories of European integration, including those focusing on integration through law and the role of rights, and have experience in developing working papers and collaborating with academics (e.g. from our advisory board). You will also have the ability to operationalise theoretical concepts for comparative qualitative socio-legal research. You will be working closely with Professor Schiek, to elaborate the theoretical framework of furthering European integration through rights in the first year, and in subsequent years contribute to devising parameter for the socio-legal research, supporting the PhD researchers as well as reconsidering the theoretical frame in the light of legal and empirical findings.
